SECTION 4: First Aid Measures

Flash Point: Non-Flammable, Non-Combustible

Extinguishing Media: Dry chemical, CO2 or water spray.

Specific Hazards: In a fire or if heated, a pressure increase will occur and the container may burst.

SECTION 6: Accidental Release Measures
