CITRUS CLEAN is a concentrated, all natural high powered graffiti cleaner/remover. It doesn't contain methanol, methylene chloride or other solvents that are commonly prohibited in projects and states.

CITRUS CLEAN is designed to remove graffiti markings from surfaces protected with **PERMASHIELD SACRIFICIAL** (4200) or **NON-SACRIFICIAL** (5300, 5400) only.

BASIC USES:

CITRUS CLEAN's intended use is to remove and clean graffiti from interior or exterior, painted or unpainted vertical surfaces previously coated with **PERMASHIELD**. It is recommended for concrete walls, highway structures, shopping malls, civic or mass transit stations, municipal facilities, factories, office buildings, apartments, schools, etc.

ADVANTAGES:

- Easy-to-use.

- Excellent cleaner for cold-water removal of **PERMASHIELD SACRIFICIAL**.
- Rinses easily with cold or hot water.

SURFACE PREPARATION:

Protect the surrounding painted surfaces, non-masonry materials, ground cover and foliage from splashing and remover residue. Maintain adequate ventilation when working on interior surfaces.

APPLICATION:

(STIR OR SHAKE WELL BEFORE USING)

- **ALWAYS TEST** each surface type, paint coating and graffiti stain before application to ensure suitability and the desired results. Allow the test areas to dry thoroughly before inspecting.
- Do not dilute, use as-is over **PERMASHIELD GRAFFITI CONTROL COATINGS** (*Items 4200, 5300, 5400*).
- Apply **CITRUS CLEAN** with a brush, roller or sprayer then allow the cleaner to penetrate into the surface for approximately two minutes. Do not allow **CITRUS CLEAN** to dry on surface. Rub the wet area with a stiff brush, nylon bristle brush, or rough sponge in a circular motion. Then flush with **CITRUS CLEAN** periodically to maintain a moist surface. Repeat the process until the graffiti is removed.
- On porous or textured surfaces such as concrete blocks, split face blocks, and textured stucco, work the cleaner into the crevices and rough edges. Multiple applications may be required for such surfaces. A rag to catch run downs is recommended.
- Rinse the surface thoroughly with water after the graffiti is completely removed.

PACKAGING:

CITRUS CLEAN is available in quart sprayer bottles (Item NO. 9700-32) and one-gallon cans (Item No. 9700-01).

SPECIAL NOTE:

CITRUS CLEAN completely removes **PERMASHIELD SACRIFICIAL**. Re-coat areas where the **PERMASHIELD COATINGS** have been removed during cleaning.

CITRUS CLEAN tends to soften **PERMASHIELD NON-SACRIFICIAL COATINGS**. This is temporary and **PERMASHIELD N.S.** will return to its original hardness when dry.

SPECIAL PRECAUTIONS:

1. Rubber gloves should be worn while using **CITRUS CLEAN**.
2. Avoid frequent or prolonged exposure.
3. Avoid contact with eyes, skin or clothing. Wear eye protection and protective clothing. Wash personal contact areas thoroughly after handling.
4. Use in well ventilated areas.

FIRST AID:

Skin Contact: Wash with soap and water.

Eye Contact: Flush with large amounts of water. Then proceed to get medical attention.
