PRODUCT DESCRIPTION:

ACCELERATOR P200 is a liquid additive designed to minimize the PERMASHIELD 200's cure time for quicker return to service. The PERMASHIELD 200 is a two-component, water based aliphatic polyurethane that displays top tier chemical resistance and stain resistance for vertical and horizontal surfaces.

MIXING INSTRUCTIONS:

- Add and mix ACCELERATOR P200 into Part A of PERMASHIELD 200 until homogeneous mixture and color is obtained or for 3-5 minutes, if mixed by hand.
- 2. When ready for application, add Part B to Part A and mix well until homogeneous mixture and color is obtained.
- 3. Pot Life: 15-20 Minutes

Caution! Do not add the **ACCELERATOR P200** into Part B (the hardener).

MIXING RATIO:

- Add 2 ounces of ACCELERATOR P200 to a 1-Gallon Kit of PERMASHIELD 200.
- Add 10 ounces of ACCELERATOR P200 to a 5-Gallon Kit of PERMASHIELD 200.

CAUTION:

- •Do not apply the accelerated **PERMASHIELD 200** when the surface temperature is below 50°F because it may affect how the product dries.
- •Do not apply the accelerated **PERMASHIELD 200** when the surface temperature is above 70°F because the pot life and dry time will be further accelerated.

•Additional amount of **ACCELERATOR P200** can improve drying time substantially; however, the pot life of the mixed products will decrease as well. Always test.

APPLICATION LIMITATIONS:

Adding **ACCELERATOR P200** will lower the standard gloss of the finish coat to the following:

- •Gloss will become a Semi-Gloss
- •Matte will become a Flat

IMPORTANT

Pot Life: 15-20 minutes. There will be slight foaming at the top of the mixed PERMASHIELD 200 when the pot life has been reached. *Discard materials after 15-20 minutes (when the foaming begins) because the color will not be consistent.

SHELF-LIFE & STORAGE:

ACCELERATOR P200 has a shelf life of one year. Protect from the effects of weathering and store at temperatures between 41° F and 86° F. Once open, containers should be resealed immediately after each removal of the product.

It must be protected against frost.
